In reference to the Press Statement by the Attorney General on the issue of Seafield Temple on December 14, the Selangor Government welcomes the Attorney General's statement on the issue of Seafield temple. Hence, the Selangor Government is of the opinion that 0.4 hectares of land (1 acre) and compensation money of RM1.5 million given by the developer should be returned. On December 14, the issue of Seafield's temple that caused riots last month, reached a new agreement with the lawyer involved in land ownership and trust management.

Attorney-General, Tommy Thomas said he had witnessed the settlement of the developer of One City Development Sdn Bhd, to transfer the land title, which is now illegally occupied by the temple, to a trust to be administered by the High Court.

He said the transfer was "subject to terms to be agreed".

Earlier, the Sri Maha Mariamman Temple in Subang Jaya had to be relocated as is per High Court Judgement where the developer would provide the land for a new temple, and a contribution of RM1.5 million.

However, riots occurred when some people acted out of control and a firefighter was gravely injured and subsequently passed away.

ecently, a Chapter Agreement was signed between Think City and the International Network of Traditional Building, Architecture and Urbanism (INTBAU) in London to recognize Think City as the official host of INTBAU Malaysia.

Dedicated to creating better places through traditional building, architecture and urbanism, INTBAU Malaysia represents the 33rd chapter of the global INTBAU network.

The INTBAU was established back in 2001 with about 6,000 members in over 100 countries worldwide under the patronage of its founder, His Royal Highness The Prince of Wales.

According to Lee Jia Ping, Programme Director of Think City, who was at the helm of signing the agreement on behalf of Think City, the aims of INTBAU are closely aligned with much of what is in the pipelines for Think City.

"Our close relationships with both the Getty Conservation Institute and the Aga Khan Trust for Culture, as well as our work with the Malaysian Institute of Planners (MIP) and Pertubuhan Arkitek Malaysia (PAM) has looked at how we can leverage our existing built heritage to make our cities more liveable, and using traditional building and design principles to enhance our decision making today", said Lee. Think City will also look to partner with

It is undeniable that much of traditional town planning has made our cities safer and more pleasant to be in; an emphasis on the pedestrian and active streetscapes are two examples.

One of the main missions of INT-BAU is to support traditional buildings in which building materials are usually more sustainable than the commonly used concrete, and are often drawn from renewable resources that have less impact on the environment.

This is due to the fact that traditional building materials, when combined with traditional designs, will oftentimes provide better protection from our country's tropical climate through their natural ventilation and cooling effects.

"With the impacts of climate change becoming more apparent every year, we need to rethink how we design and construct our buildings," added Lee.

As such, INTBAU Malaysia will allow Think City to leverage INTBAU's global network as a resource, drawing on the expertise of professionals from all over the world.

"We will be hosting a number of events to raise awareness of the local Chapter, including capacity building, public talks, and forums. These will be targeted at not only professionals but also towards students that will be tomorrow's city makers."

"Think City will also look to partner with other Chapters to work on a physical project that can best highlight the principles of traditional building and architecture, while at the same time trying to ensure that the practices can be implemented in existing projects," Lee concluded.

Azmin – Malaysia to Reduce Oil Output

Malaysia's commitment to reduce the oil output is in line with the fifth Opec and non-Opec Ministerial Meeting in Vienna, Austria which saw oil producing countries agreeing to reduce oil production to 1.2 million barrels per day for the next six months from 1.8 million barrels per day.

"Even though we are a small oil producing country, Malaysia stands in solidarity with oil producing countries in pursuing the strategic objective of achieving global market stability in the interest of all oil producers and consumers, taking into consideration the prevailing market conditions and prospects.

"Malaysia views highly this collaboration to strengthen cooperation between members of Opec and non-Opec countries to face challenges posed by the global market," said Azmin.

The Minister of Economic Affairs said this decision is a testament of Malaysia's commitment to international cooperation to face economic challenges posed Malaysia views highly this collaboration to strengthen cooperation between members of Opec and non-Opec countries to face challenges posed by the global market, by the global oil market.

The commitments made under this proactive collaboration between participating countries were to be voluntarily implemented, non-binding and would not in any way affect the rights of peoples and nations to permanent sovereignty over the exploitation and management of their natural resources.

Furthermore, the global market reacted positively when oil prices climbed at the conclusion of the meeting, added Azmin.

As part of his working visit to Vienna on Dec 4, Azmin led Malaysia's participation in the 12th Meeting of the Joint Ministerial Monitoring Committee, the fifth Opec and Non-Opec Ministerial Meeting and the anniversary dinner celebrating the landmark Declaration of Cooperation.

The Malaysian delegation to Vienna included representatives from the economic affairs ministry, the Attorney-General's Chambers and Petroliam Nasional Bhd (Petronas).

Fair and Equal State Budgets

ecently, two states with the strongest economies in the country - Johor and Selangor unveiled their budgets for the coming year, with the latter even announcing an allocation for eSports.

Coincidentally, both the state budgets are based on six main thrusts, with both Menteri Besar anticipating strong economic growth in 2019.

The Selangor budget was announced by its Menteri Besar, Amirudin Shari, while the Johor budget was announced in Iskandar Puteri by Menteri Besar Dato' Osman Sapian.

According to political observers, both state budgets were well-focused and catered to the needs of all walks of society.

For example, among the thrusts highlighted in Johor's budget is the well-being of people, while similarly, for Selangor, there is focus on education, social and rural development.

"What the rakyat are most focused on these days is what the government is going to do to enhance their livelihoods. They are not interested in allocations for administration and infrastructure, but mostly on what the budget can do for them," said the observers.

Selangor's budget 2019, tabled last month, worked out to RM2.56 billion, compared to the RM3.2 billion budget tabled in 2017, while Johor announced a state budget with a projected surplus of RM3.43 million.

The excess revenue for Johor was an increase of RM2.29 million from this year's budget by the previous Barisan Nasional (BN) government.

There was also joy for low-income households in Selangor, known as the B40 group, as the Menteri Besar said they would enjoy an increase in the amount of free water they receive from 20 cubic metres to 25 cubic metres of water under the 2019 Budget.

Realising the plight of aspiring house buyers, Selangor set aside RM1 billion to help people in the state to own homes.

The state is looking to achieve this through bank partnerships under their rent-to-own scheme.

There was also plenty to cheer about down south as Osman announced that the Federal Government had agreed to write off Johor's bad debts amounting to RM189 million.

Civil servants from both states also had plenty to cheer about as Johor announced a special payment of RM1, 500, while Selangor civil servants will receive a month's salary.

"Keeping the nation's strong civil service happy is important and this is something both states have paid attention to," said an assemblyman from Selangor.

The six thrusts in Johor's Budget 2019 are namely ensuring the people's prosperity; sustainable development and preservation of resources; infrastructure development, dynamic democracy and social equality; driving trading zones and the digital community; modernising Islamic education, human capital and cultural heritage and efficiency, integrity and democratic administration.

As for Selangor, the state budget of RM2.56 billion is based on six main thrusts of infrastructure, economy, education, social, rural development and health while prioritising physical development.

However, for Selangor, the budget will have a deficit of RM360 million.

This, according to Amirudin is due to the substantive development allocation to meet the needs for sustainable development. Keeping the nation's strong civil service happy is important and this is something both states have paid attention to,

Johor will enjoy a surplus budget of RM3.43 million for next year as the state government is expected to collect total revenue of RM1.552 billion while expenditure is expected to be RM1.549 billion.

"This is attributed to effective state fiscal policies, along with prudent spending, integrity and effective management of sustainable resources," said Osman.

Other highlights of the Johor budget include the rebranding of the Johor State Investment Centre (JSIC) set up in 2014 to Invest Johor which the Menteri Besar said was aimed to further strengthen the state as the leading investment destination in the country.

Invest Johor would focus on attracting high technology investments from potential companies, including those from China, Japan, France, Singapore, South Korea and the United States.

According to Bukit Batu assemblyman Jimmy Puah Wee Tse, who is the executive councillor for Investment and Utilities, Johor was working towards aggressively drawing more foreign investors to the state and the rebranding exercise was among one of the strategies.

"China is a growing giant and we are looking to tap as much investments from them as possible," he added.

Apart from the very people-friendly Selangor budget, another aspect that attracted attention was the allocation made for the development of eSports in the state.

According to Amirudin, who also oversees the empowerment of youth and sports in the state, this was necessary due to the growing popularity of eSports in the country.

"eSports is becoming very popular among our youth and we need to pay equal emphasis to its development. It is no longer just something done during their leisure time, but has grown to become a global competitive sport," he added.

Apart from the RM400, 000 allocation, Selangor will also be looking to obtain RM1 million from the federal government in hopes of pushing development of eSports into the regional level.

Overall, the maiden budgets for both Menteri Besar seem to have taken due consideration of the needs of people from all walks of life - from housing, education and social needs.

According to Selangor executive councillor for environment, green technology and consumer affairs, Hee Loy Sian, the state budget was drafted to ensure no group was left out, with focus on helping to uplift the living standards of the less privileged in the state.

Political analysts said both the state budgets were fairly balanced and ensure equal distribution to all people in the state.

Malaysia's PNB And EPF Acquire Battersea Commercial Property For \$2 Billion

KUALA LUMPUR – Malaysia's largest asset management firm Permodalan Nasional Bhd and state pension fund Employees Provident Fund (EPF), known as PNB-Kwasa International 2, have agreed to jointly acquire the commercial assets at London's Battersea Power Station for 1.58 billion pounds (\$2 billion).

PNB-Kwasa International 2 is a joint venture of Permodalan Nasional Bhd (PNB) and the Employees Provident Fund (EPF).

In a joint statement issued by SP Setia and Sime Property, the development was a major step in the ownership reorganisation for Phase 2 of the Battersea Power Station commercial.

"We are pleased with the sale of the Phase 2 commercial assets. It will bode well with our business plans as we continue to play a major role in the overall development of this iconic project. SP Setia is fully committed and positive on the long-term prospects of the project," said SP Setia president and CEO Datuk Khor Chap Jen.

"We would like to thank all the parties involved in evaluating this acquisition and making this transaction a success. The commitment shown by all demonstrates the confidence in this iconic London landmark development," Khor said.

Battersea Phase 2 Holdco is a unit of Battersea Project Holding Company Ltd, which is owned by Sime Darby Property Bhd and S P Setia Bhd, each holding a 40% stake, and EPF holding the remaining 20%.

"This is an important milestone in the development of the Battersea Power Station site, and it is a strong sign of confidence in the long-term success of this global property icon. We are pleased to have secured this commitment from two of Malaysia's leading institutions," said Sime Darby Property Group managing director Amrin Awaluddin.

The acquisition was targeted to be completed in the first quarter of 2019, the funds said in a joint statement.

Battersea Phase 2 is part of the restoration of the iconic Power Station building expected to be completed at the end of 2020 and open to the public in the following year.

Built in the 1930s, the power station stopped operating in 1983 and gradually fell into disrepair. Multiple attempts to redevelop it fell through due to costs and practical difficulties in converting the gigantic site.

on early intervention. In the long run, Khairul plans to take Headstart into its second phase by introducing a programme for older children. The programme will not only highlight academic skills, but also include a structure where special needs children can learn vocational life skills, structured play and address their sensory issues. Khairul adds that his vision is to see Headstart Academy become a franchise for quality private special needs education for all ages and hopefully someday, build a full-fledged school for special needs' children.

"I wanted to start a full-on school to cater to older children, like Ayden, too. I wanted to build a place that I would want to send my own child because at the end of the day, it's tough for any parent to say that their child will never be typical or do things that typical children can do. I'm not an educator but as a parent, I know how



important it is to have a place where your child is happy."

However, an assertive entrepreneur, Khairul is aware that Headstart needs to establish its credibility within the industry and demonstrate that its model works, before any plans for expansion take place. "I wanted to start a place that's marketable and could become commercial in the long-run. Down the line, as we expand, we look forward to collaborations with the state government and other partners."

As Headstart Malaysia opens its doors next year, Khairul says he plans to extend its role by engaging the special needs community through outreach programmes. As of now, Headstart currently sponsors space for the Autism Café Project at its lounge area where families can enjoy food and drinks served by special needs youth. Further down the pipeline, Headstart plans to offer its space for community programmes as well as sponsor PPKI classes in their impressive gym.

Giving Special Needs Children A Head Start In Life

the shock of the diagnosis and making decisions for intervention, parents of special needs children face several unique challenges; one of which is the unfortunate realisation that mainstream education does not fully accommodate children with special needs. Khairul Ramly, the founder of Headstart Academy knows these feelings and challenges all too well as the parent of a special needs' child.

eyond coping with

Grappling with reality

Khairul's own son, Khayr Ayden, was diagnosed on the autism spectrum back in 2010 when the family was living in Singapore. Determined to ensure as fulfilling a life as he could for Ayden, Khairul and his family embarked on the hunt for an early intervention programme that catered to Ayden's needs. He discovered the Saint Clare School for Special Education which implements an Individualised Education Programme (IEP) that identifies each child's skills and needs and provides personalised special education

services. Through this personalised programme, Ayden saw improvements in several areas of his development.

However, upon returning to Malaysia, like many parents of children on the spectrum, Khairul was struck with the reality that intervention for children on the Autism spectrum in our nation is focused mainly on early intervention. Scouting through several schools and intervention centres, Khairul was unable to find a school that offered comprehensive therapies to prepare Ayden, who was by then 8 years old, for school and life beyond. In addition to that, the existing early intervention centres were simply put, poorly maintained and in Khairul's eyes, did not provide the adequate support that his son needed.

Taking charge

While most would begin to feel helplessness at the predicament and uncertainty of their child's future, this only further spurred Khairul towards a new mission: building a path into adulthood for Ayden and other children like him so that they could get a head start. Having seen the positive impact that the IEP model at Saint Clare's had on his son, the idea sparked within Khairul to establish an intervention academy with the same premise - a child-centric personalised curriculum to develop each child's potential and abilities. Thus, the Headstart Academy Malaysia was born.

"Parents of special needs children don't have a wide choice of schools and the point here is to create the choice. grammes that creates a more personalised programme for their children. We want to create a benchmark for what private special needs education should be. We want to disrupt the industry and drive competition to increase the quality of special needs education out there."

Headstart Academy provides a premier early intervention programme for younger children with special needs utilising a proven international curriculum that is delivered by experienced, fully-trained academic staff with a passion and an invested interest in what they do.

Khairul says, "The way the business was set up ensures 30 percent equity is divided between the team. I wanted my team to have a stake in the business to give them ownership over running the business. child as well as the family. It is also an opportunity for parents to assess their child in the environment at the academy so that they can be comfortable with their deci-

sion to (or not to) enroll their child. For two to three weeks, the child attends classes to ensure the academy is a good fit and is evaluated by three different therapists – Behavioural, Speech and Occupational - at no cost. Teachers and therapists then sit down with parents to discuss the child's development and progress before enrolment.

Leading the way

The flagship Headstart Academy spans over 10,500 square feet of space specifically designed for special needs' children. It boasts a 2,000 square foot Occupational Therapy Gym with a rock-climbing wall and other equipment more impressive than most gyms in typical schools. Other premium facilities catered to engage its students include therapy rooms, dedicated areas for arts & crafts, music, dining and changing rooms/toilets. There is also a Snoezelen sensory room, which is a controlled multisensory environment designed to deliver various soothing stimuli to the senses using lighting effects, colour, sounds. music, scents.




